INSTRUCTIONS

- 1. Please read the instructions given below carefully. If the nomination form is not filled as per instructions, the same will be rejected.
- 2. The nomination can be made by individuals only.
- 3. If the Bonds are held jointly, all joint holders will sign (as per the specimen registered with the Company) the nomination form.
- 4. A minor can be nominated by a holder of the Bonds and in that event the name and address of the Guardian shall be given by the holder.
- 5. The nominee shall not be a trust, society, body corporate, partnership firm, Karta of Hindu Undivided Family or a Power of Attorney holder.
- 6. Transfer of Bonds in favour of nominee and repayment of amount to nominee shall be a valid discharge by the Company against the legal heir.
- 7. Only one person can be nominated for a given folio.
- 8. Details of all holders in a folio need to be filled; else the request shall be rejected.
- 9. The nomination will be registered only when it is complete in all respects including the signatures of all registered holders (as per specimen lodged with the Company).
- 10. Whenever the Bonds in the given folio are entirely transferred or transposed with some other folio, this nomination will stand rescinded.
- 11. Upon receipt of a duly executed nomination form, the Registrar and Transfer Agents of the Company will register the form and allot a registration number. This number and folio no. should be quoted by the nominee in all future correspondence(s).
- 12. The nomination can be varied or cancelled by executing a fresh nomination form.
- 13. The Company will not entertain any claims other than those of a registered nominee, unless so directed by a Competent Court.
