7. Only buyers holding valid User ID/ Password and confirmed payment of EMD through Demand Draft in favor of “**IDFC FIRST BANK LIMITED**” shall be eligible for participating in the e-Auction process.

The interested bidder has to submit their Bid Documents [EMD (not below the Reserve Price) and required documents (mentioned in Point No.4)] on/ before **24.12.2020 UPTO 05.00 PM** by way of hardcopy to the Authorized Officer.
