Section 194N of the Income Tax Act, 1961 requires every banking company, to whom the Banking Regulation Act, 1949 applies, to deduct taxes at source at the rate of 2% on payment of any sum, in cash exceeding INR 1 crore during the year.

The provisions also require that in case the recipient has not filed its return of income for all the three assessment years relevant to the three previous years, for which the time limit of filing return of income has expired\*, immediately preceding the previous year in which the payment of the sum is made to him/her, the taxes required to be deducted by the bank shall be:

- (i) 2% where the amount or aggregate of amounts being withdrawn in cash is between <u>INR 20 lakh and INR 1 crore</u>; and
- (ii) 5% where the amount or aggregate of amounts being withdrawn in cash exceeds <u>INR 1 crore</u>

The tax will be deducted on the amount of cash withdrawal made during financial year **2023-24** in excess of the applicable limits.
