The Trust undertakes only philanthropic activities.</p> <p>3) In terms of RBI New Banking Guidelines and other applicable laws, both IDFC Limited and IDFC Financial Holding Company Limited ("IDFC FHCL") are construed as Promoters of IDFC FIRST Bank Limited. The Bank had executed Corporate Action with the Depository for the said allotment and the same was received from Depository on October 09, 2023.
