Textual Information()

1) The voting rights on the shares will be as per the provisions of Banking Regulation Act, 1949, as amended from time to time.

2) Rukmani Social Welfare Trust is a Trust set up and managed by Mr. V. Vaidyanathan, where he is a Trustee. The Trust undertakes only philanthropic activities.

3) In terms of RBI New Banking Guidelines and other applicable laws, both IDFC Limited and IDFC Financial Holding Company Limited ("IDFC FHCL") are construed as Promoters of IDFC FIRST Bank Limited. However, IDFC FHCL is a wholly owned subsidiary of IDFC Limited and accordingly, IDFC Limited indirectly holds 37.37% of total paid-up voting equity capital in the Bank (i.e. 7,08,11,21,439 equity shares) as on June 30, 2024 through IDFC FHCL.

As mentioned above, since IDFC Limited indirectly holds equity stake in IDFC FIRST Bank and the entire aforesaid equity stake is solely and directly held by IDFC FHCL, we only mention IDFC FHCL under Promoter & Promoter Group in XML taxonomy of SHP submitted to Stock Exchanges.

4) The duly authorized Committee of the Bank has on June 20, 2024, approved the allotment of 38,44,596 equity shares of face value of 10 each fully paid-up to the eligible employees, upon exercise of stock options. The corporate action for said allotment has been executed. However, the listing and trading approval was still awaited from Stock Exchange as on June 30, 2024.
